1. Sealed tender for the supply of the articles shown in the attached statement are invited by the undersigned on behalf of Eklavya Model Residential School, Hirli, Nabarangpur. Last date of issue of the tender form is up to **01.30 PM** on Dtd. **01.09.2025** and last date of submission of the tender papers up to **05:00 P.M.** on Dtd. **01.09.2025** by **Speed Post/ Regd. Post / by hand** only. The tender should be sent in a strong sealed envelope with marked as “**TENDER FOR THE SUPPLY OF**” on the top of the same. The tender will be opened in the **Office of the Principal, EMRS, Hirli, Nabarangpur** on **Dt. 03/09/2025 at 10.00 AM**. The bidders/ their representatives must remain present.
2. The selection of items will be based on the approval of Purchase Advisory Committee and the quality of the items may be taken into consideration.
3. The tender paper should be submitted according to the terms and conditions specified below in tender form.
4. Individual envelope containing tender papers for different category items should be submitted by the bidders.
5. ***The Tender Box will be unsealed at 10.00 AM but the tender forms will be opened for the items mentioned from Sl. No. 01 to 05 and 12 to 15 from 10.30 AM to 01. PM and remaining tender forms will be opened after lunch hour i.e. 02.00 PM onwards. All the bidders should submit their samples before 10.30 AM***
6. The details description for uniform items given by the NEST, New Delhi is available in the Nabarangpur District Website and Office of the EMRS, Hirli, Nabarangpur. The bidders must bring the sample as per the description. Other than description materials will not be entertained.
7. ***There should not be any over writing, corrections in the Tender paper.*** If a figure is to be amended, it should be neatly scored out and then revised figure should be written above and the same should be attested with full signature and date. In the absence of the attested signature the tender is liable to be rejected.
8. The Bidder Should Submit his/her tender form along with original money receipt, If the bidder obtains the tender paper from District Website www.nabarangpur.odisha.gov.in and school website i.e. www.emrhirli.com, he/she should enclose a Demand Draft of Rs. 200 (Two Hundred) in the below mentioned name, in a separate envelope with the tender document. The bidder should enclose

Earnest Money Deposit (EMD) with tender paper as specified in **SI No. 17**. In form of **Bank Draft in favour of EKALAVYA MODEL RESIDENTIAL SCHOOL, HIRLI, payable at SBI, Main Branch, Nabarangpur (Only Nationalised Bank)** which will be refunded to unsuccessful bidder with due procedure. The earnest money deposit (EMD) will be forfeited in the event of failure to comply with contract. In the event of the tender being accepted, the earnest money shall be retained as a safeguard against any defect appearing in the articles supplied within the period of deposit. No interest is payable on EMD.

9. The quantity of articles indicated in the attached statement may be increased or decreased or nil at the discretion of the undersigned without assigning any reason.
10. The **hiking of price** of any article in the tender period mentioned here is strictly prohibited. No request regarding this matter is to be considered.
11. In the event of acceptance of the tender and placing of the order for purchase, the articles ordered for would be subjected to inspection by the undersigned/ Physical Verification Committee/Concerned Person and are liable to be rejected the article supplied, if not according to approved samples or do not confirm to the specifications prescribed.
12. In no case the payment will be made above **MAXIMUM RETAIL PRICE (MRP)**.
13. If the bidder does not satisfy the terms and condition and supply goods & services in time the tender may be cancelled and EMD will be forfeited and given to the next bidder for smooth functioning of the institution. The undersigned has right to reject this tender at any time without any prior notice which can't be challenged under any court of law.
14. No advance money will be paid to any bidder. Measurement of students and distribution of uniform must be done in the presence of the bidders/ their representatives with concerned school staff. But, the measurement of girls will be taken by providing a lady tailor. Bidders must supply the dress materials and other uniform items as per the actual measurement and size taken by him.
15. The quoted by the Contractor shall hold goods from 01.10.2025 to 30.09.2026. for the branded items, if there would be some free gift schemes, marked on the packing, the same would liable to be supplied with the articles on free of cost also and also mention in the bill.
16. No Interest will be paid by the undersigned for the EMD kept in this school.
